Agreement For Supply of Water For Domestic/Commercial/Industrial

Purposes

An agreement made on this the _____ day of _____ in the year

_____ between _____ hereinafter

called the consumer which terms shall include the said party (his heirs, successors and assigns) the first part & the (hereinafter called the supplier) of the other part.

Whereas the suppliers has agreed to supply water for domestic/commercial/Industrial purposes and the consumer has agreed to abide by the terms and conditions hereinafter mentioned.

NOW THE PARTIES AFOREMENTIONED HAVE AGREED AS FOLLOWS

1. The department shall supply water to the consumer at his premises situated at _____ for the purpose of domestic/commercial/Industrial purpose & for which rates may differ.
2. The department shall take all reasonable precautions for making regular supply of water but will not be responsible for my interruption or any loss occurring there from due to circumstances beyond the control of the supplier.
3. The department shall be at liberty to temporarily cut off the supply at any time after a reasonable notice to the consumer & repairs to any mains of apparatus or any machinery at the pumping stations or due to flood etc.
4. The supply shall be registered by a meter or made on flat rate & in case the supply is registered by the meter is shall be supplied & fixed upon the premises by the suppliers. The consumer shall make good any damage to or loss of the said meter (or any other fittings etc belonging to a supplier). The consumer will not however be responsible for making good the loss or damage of the meter, if the loss or damage have been occasioned by causes beyond the control of the consumer.

2. The consumer shall allow to the supplier representative free access with due notice at all reasonable times during day light for making down the reading of the meter or meters & for general maintenance of the installation.

3. The consumer shall pay charges of water supply & rent of the meter at the rates & within the time specified in water supply scheme. The consumer will be at liberty to pay such charges in advance for the whole year, six months or three months.

7. The consumer will have to properly maintain a number plate showing the number of this installation at very prominent place of his house e.c. the front door-falling which the installation will be disconnected & will be reconnected only when the plate is replaced & disconnection & reconnection charges are paid. The supplier at the consumer's cost will supply the plate to the consumer.

8. The Consumer shall observe the general rules regarding the supply of water as provided in the water supply rules or as may be issued by the supplier from time to time.

9. The department shall supply water to consumer in his premises at the general level. The department shall be responsible for providing water beyond ground level to any other floor level and at the pressure as exists till date.

10. The consumer shall make arrangement on his own for sufficient storage capacity at the ground level. The consumer shall not register any complaint / protest with reference to Page No. -3.

11. I _____ S/o _____ R/o _____

solemnly affirm & declare that land papers enclosed for getting water connection doesn't mean the legal right of the ownership of the land.

Any dispute regarding the land if arises with any party at any moment, the department shall be at liberty to disconnect the water connection without any argument / plea of any sort till the decision from the competent authority (Revenue deptt.) and the water connection shall be purely temporary.
